The meeting was called to order at 5:32 pm, by Chair, Aram Wheeler

**Chair Wheeler made a motion approve the agenda as written. Commissioner Weber seconded. Motion carried.**

Ms. Burbidge announced the Lacey Depot & Playground Grand Opening is being held May 25<sup>th</sup> at 5:30 pm. The new website has launched at laceyparks.org.

**Old Business**

- a) Greg Cuoio Park Phase 1A – Ms. Burbidge updated the Board on the site plan.
  - City Council gave approval to move forward with the Phase 1A design.
  - Staff met with the consultants to set a design timeline.
  - Walkthrough was done with the consultant and South Puget Sound Disc Golf Association.
  - Next walkthrough is with City staff on May 12<sup>th</sup> with the consultant.
  - Grant applications in two RCO categories were submitted on May 3<sup>rd</sup>.

- b) Park Board Tour Reschedule – The Park Board tour of the Greg Cuoio Park grounds will be rescheduled for next month.
- c) Comprehensive Plan PIP – Ms. Burbidge reviewed the Public Involvement Plan with the Commission on Equity and it was approved to move forward.

**Chair Wheeler made a motion to approve the PIP. Commissioner Kirby seconded. Motion carried.**

### **New Business**

- a) New Alcohol Event Permits – Commissioner Kirby recused himself from this action due to personal involvement. Chair Wheeler invited Commissioner Kirby to provide further details about the event. Ms. Burbidge reviewed the alcohol policies and clarified a new event permit needs to be approved by the Board.

**Chair Wheeler motioned to approve the new event alcohol permit for Cider Fest at Huntamer Park pending the appropriate City staff review. Commissioner Good seconded. Motion carried.**

- b) Facility Policies Update – Mr. Beard informed the Board the facility policies for Lacey Community Center and Jacob Smith House are being updated to be more uniform, changes are mostly language based and include updated facility closure dates.

**Chair Wheeler motioned to approve the policy updates. Commissioner Goodwin seconded. Motion carried.**

- c) RAC Policies Update – Ms. Falash advised these updates are similar to the facility policies updates. These updates were reviewed by the Commission on Equity and are mostly language, formatting, and dates of closure changes.

**Chair Wheeler motioned to approve the RAC policy updates. Commissioner Weber seconded. Motion carried.**
