Children's Day Policies: Please review and check/initial.

- All Children's Day booths shall include games, activities, giveaways, crafts, or prizes for kids and shall align with the objectives of the event as stated on this application. Participants should plan on enough items to last through the event hours and/or have a backup activity just in case.
- Children's Day activities are to be provided for FREE to the public. Selling items or services, or soliciting for donations is prohibited. Participants must stay within their allotted booth space.
- All booths shall be set up between 9-10 am on Sat. Oct. 5 and be ready for families by 10:30 am. **Booths must be staffed for the entire event: Sat. Oct. 5, 11 am - 2 pm and may not breakdown or leave prior to event closing (rain or shine). Failure to provide adequate staffing for the event or adhere to event policies/requirements will cause reconsideration of your organization's participation in future events.**
- Participants must provide their own tent/canopy, tables, chairs, and a **banner/sign** to identify their organization. Spaces are outside and tents must be weighed down. We recommend aligning your booth to the theme (Circus), but this is not required.
- Participants that are granted power must bring their own extension cord(s). Participants agree to remove all garbage & debris from their booth area at the end of the event. Note: dumpsters/cardboard recycle provided on site).
- The objectives of Lacey Children's Day are to build community pride & identity and to provide an event that offers fun activities & educational opportunities for families & people of all ages. In view of these objectives, booths and/or space will not be made available to groups, businesses, or individuals for the purpose of advocating a particular political, social, or religious point of view. In the conduct of the event, individuals will not be allowed to solicit outside of established booths/space for the purpose of monetary gain, or for the advocacy of a particular political, social or religious point of view.

Indemnification and Agreement:

I (we) understand that Lacey Children's Day is a FREE activity area and prohibits selling and/or soliciting donations of any kind. I (we) and our heirs, executors, and administration further agree to waive and release any and all rights and claims or damages we may accrue against the City of Lacey, Lacey Children's Day, Sponsors, and their representatives, successors, and assignors for any and all injuries suffered by us or any of us at Lacey Children's Day. I (we) grant the City of Lacey permission to use and publish my or my child's photograph for promotional, marketing and editorial purposes in print and electronic media. No financial or other liability to me will be incurred by the City or the photographer. I (we) further agree and understand that if I (we) fail to meet the conditions as outlined in the Children's Day Policies, our participation in future Lacey Parks events could be jeopardized.
